Court Stunned by Substantial Defense Character Witness

Is Used by Solicitor to Get Suggestions Before Jury

Solicitor Mentions Names of Many Persons, Who Will Probably be Put Up in Rebuttal to Attack Frank's Conduct as Related to Women Employes of Factory—Mrs. Rae Frank, Mother of the Accused, Creates a Sensation Shouting at the Solicitor

Court adjourned at 5 o'clock Thursday morning. The trial of Leo M. Frank took another sensational turn Wednesday afternoon when Solicitor Dorsey began, through his questions to John Ashley Jones, put up as a character witness by the defense, a vigorous attack upon the character of Frank. The solicitor turned the sensational nature of the attack on the character of Frank to the jury by asking a series of questions.

"You never heard Leo T. Conroy and Miss Myrtle Clark talk about Frank walking into the dressing room," shouted the solicitor.

"You never heard how he looked at poor little Mrs. Myrtle Clark?"

"You didn't hear of her being so tried to do look at Mrs. Myrtle Clark?"

"You didn't hear how she said Mrs. Pearl Dodson hitting him with a money order?"
